### APPROVED ASSEMBLIES:

**Deck Type 1:** Wood, Non-insulated

**Deck Description:** 19/32" or greater plywood or wood plank

**System E(1):** Base sheet mechanically fastened TO deck.

**Base Sheet:** One or more plies of Fast Felt® with a minimum 4" side lap and a 6" end lap mechanically fastened to deck with approved nails at a spacing of 6" o.c. at the laps and two staggered rows 12" o.c. the field of the roll.

**Surfacing:** Approved Roof assemblies.

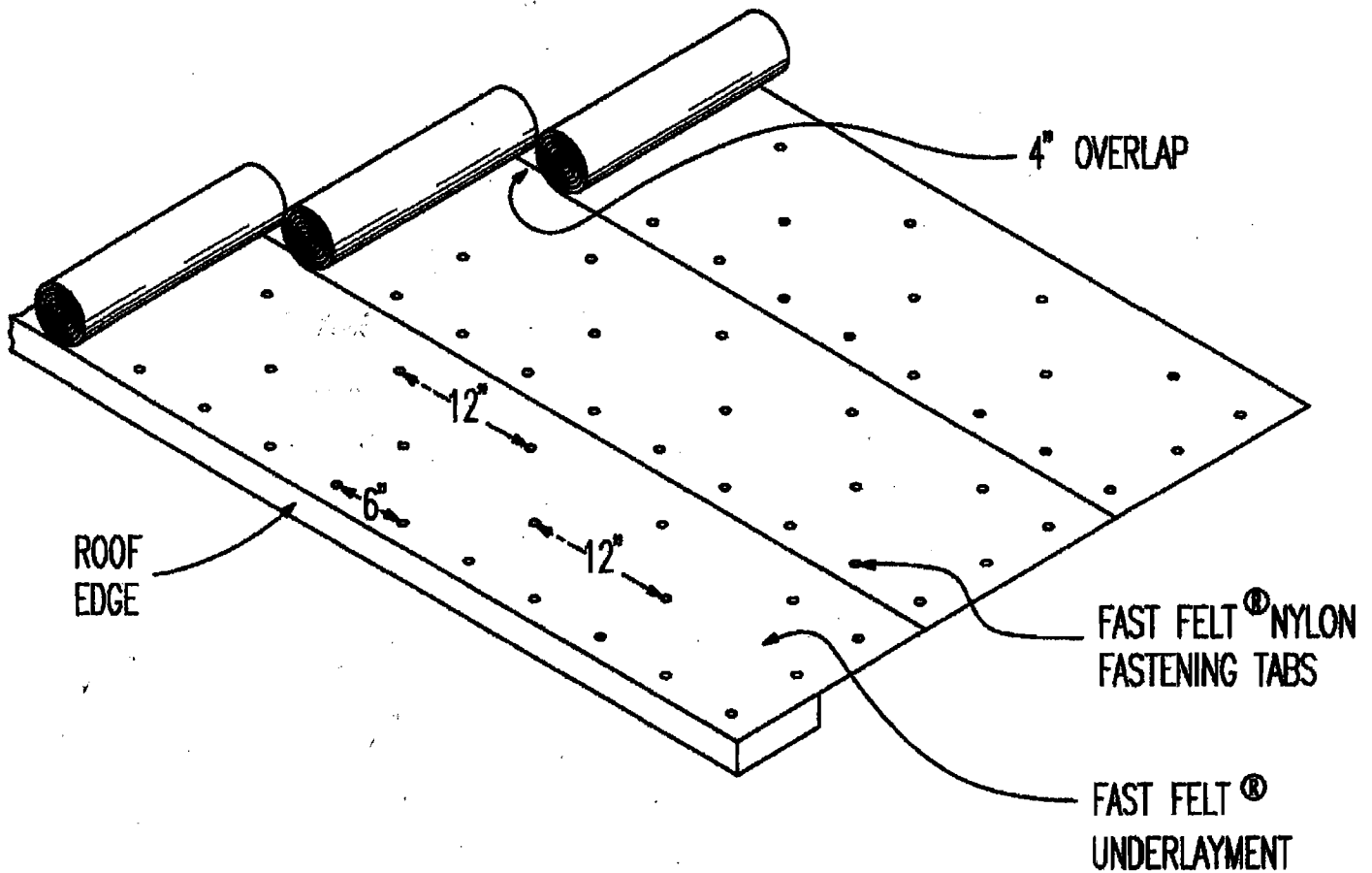

**INSTALLATION REQUIREMENTS:**

1. All nail fasteners securing Fast Felt® to the roof deck shall be nailed through the center of the Fast Felt® Nylon fastening tab (1/4" maximum deviation) which is integrally attached to the Fast Felt® underlayment. See Detail "A".
2. The flat underside of the head of each nail fastener securing Fast Felt® to the roof deck shall be driven flush to the surface of the Fast Felt® Nylon fastening tab.
3. Fast Felt® underlayment shall be installed in accordance with the applicable Roofing Application Standard that pertains to the approved roofing system in which it is used.

## GENERAL LIMITATIONS:

1. Fire classification is not part of this acceptance.
2. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with applicable building code. Fast Felt® underlayment shall be installed in strict compliance with applicable Building Code.
3. Fast Felt® underlayment shall be applied to a smooth, clean and dry surface with deck free of irregularities.
4. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
5. Fast Felt® underlayment shall not be applied over an existing roof membrane as a recover system.
6. Fast Felt® underlayment shall not be left exposed as a temporary roof for longer than 30 days of application.
7. Refer to Prepared Roofing system Product Control Notice of Acceptance for listed approval of this product with specific prepared roofing products.
8. Fast Felt® underlayment may be used with any approved roof covering Notice of Acceptance listing Fast Felt® underlayment as a component part of an assembly in the Notice of Acceptance. If Fast Felt® underlayment is not listed; a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
9. Flash vent pipes, stacks, chimneys and penetrations in compliance with Roof Assembly current Product Control Notice of Acceptance and applicable Building Code.
10. All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
